Amending the IFCC PD 1005:2021

#### 1 Introduction

In February 2021, IFCC submitted the IFCC scheme to the PEFC Council, and was assessing by ITS Global. In the assessment process, ITS Global identified nonconformity on IFCC procedure for group management (IFCC PD 1005:2021).

Based on the above assessment result, IFCC has amended the IFCC Procedure for Group Management (IFCC PD 1005:2021 issue 2).

### 2 Scope of the standard setting process and this report

This report is based on the requirement 6.3 of the IFCC standard setting procedures (IFCC PD 1001:2019).

The scope of the standard setting activities is focused on amending the IFCC procedure for group management (IFCC PD 1005:2021) in order to address the nonconformity as identified in ITS Global draft assessment report.

The standard setting work is based on and governed by IFCC PD 1001, *Standard setting procedures* and shall be open, transparent, and consensus based.

## 3 Governance of the amendment process

In accordance with IFCC PD 1001 the following organizational arrangements were applied for the amendment of the requirements:

## 3.1 IFCC Board of Directors (the BoD)

The BoD was responsible for the formal approval of the amendment of the IFCC procedure (based on IFCC PD 1001).

#### 3.2 Standardization Committee (the SC)

The SC who worked on creating the amendment of IFCC PD 1005 is the same SC who developed the IFCC PD 1005:2021.

The SC reports to the BoD; and the BoD can dissolve the SC at any time.

## 3.3 Drafting Working Group (DWG) / Task Force

The DWG/Task Force is a group of experts that supported the SC by preparing draft documentation for the SC meetings.

## 3.3 IFCC Secretariat (the Secretariat)

The Secretariat was responsible for the implementation of the standard setting procedures (IFCC PD 1001). The Secretariat arranged all contacts between the SC and the BoD. In particular, the Secretariat was responsible for:

a) Providing secretarial and administration support to the SC;

- b) Administration of the member consultation;
- c) Publication of the approved documentation.

## 4 Description of the process

In the end of August 2021, the IFCC formally started the amending of IFCC PD 1005:2021. The process consisted of 4 stages as defined by IFCC PD 1001 (committee stage, Enquiry stage, formal approval stage and publication stage).

#### 4.1 Summary of the process

The SC has met 1 time in face to screen [1.1-1.3]; members of the SC were invited in advance. The meeting was recorded in the minutes from the meeting. The SC has reached consensus.

The DWG has met 1 time in face to screen [2.1 - 2.2]. The minutes of the DWG meeting was recorded.

Enquiry draft of the document was sent for member consultation that was organized during August - September 2021<sup>[4.1]</sup>. No comments were received.

#### 4.2 Standard setting process

The detail of the standard setting process divided into 4 phases as presented below.

### **Summary of the SC meetings**

The SC started its work at its meeting held on **30**<sup>th</sup> **August 2021**<sup>[1.1-1.3]</sup>. The purpose of the meeting was (i) to receive the Draft of amendment of IFCC PD 1005 from DWG; (ii) to discuss the Draft of amendment of IFCC PD 1005. The SC reached consensus / agreed to send enquiry draft of amendment of IFCC PD 1005 for member consultation. At this meeting the SC also agreed send

the enquiry draft to the BoD as the final draft (if there are no input/comments from member consultation).

The meeting was attended by 37 members (out of 42 total members) of the SC and all of them voted in favor of the amendment of IFCC PD 1005<sup>[1.3]</sup>.

The SC therefore reached consensus as defined by IFCC PD1005:

- More than 80 % of all members voted in favor;
- There was no sustained opposition presented by any member of the SC.

## Management of the SC

The members of the SC received in advance an invitation for the meeting  $^{[1.1]}$ . The SC meeting was recorded in the minutes  $^{[1.3]}$ .

## **Drafting Working Group (DWG)**

The DWG assisted the SC with drafting the amendment of IFCC PD 1005. The DWG met on  $20^{th}$  August  $2021^{[2.1-2.2)}$ .
